

Inflation Monitor February 2016

The Consumer Price Index (CPI) rose to 7.0% in February 2016

The term inflation means a sustained increase in the general level of prices for goods and services. It is measured as an annual percentage increase (for example February 2015 to February 2016).

The year-on-year inflation rate as measured by the Consumer Price Index (CPI) rose to 7.0% in February 2016 up from 6.2% recorded in January 2016.

The Food price increased to 8.8% in February 2016 from 7.0% in January 2016.

Transport inflation increased to 8.7% in February 2016 from 5.5% in January 2016.

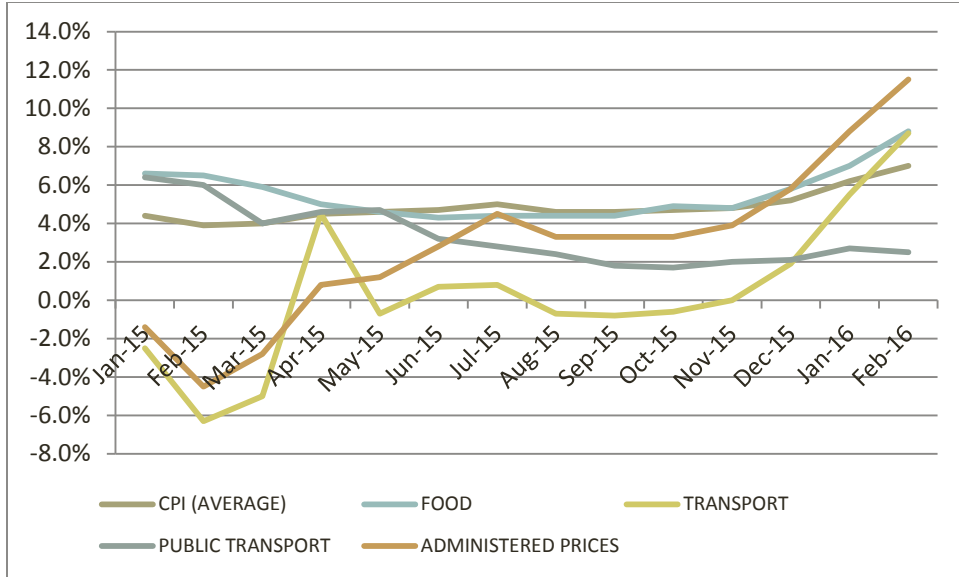
Public transport inflation decreased to 2.6% in February 2016 from 2.7% in January 2016. (Buses, trains, and other forms of transport that are available to the public, charge set fares, and run on fixed routes.)

Administrator's price (school fees, telephone fees, electricity, trains, and petrol/paraffin) increased to 11.5% in February 2016 compared to 8.8% recorded in January 2016

Consumer Price Index (CPI) Per Expenditure Quintile

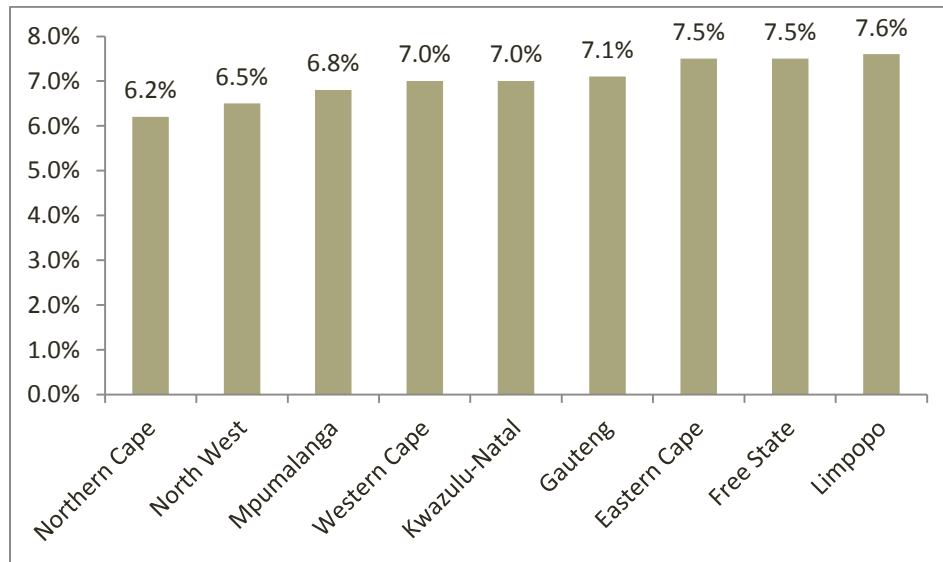
Statistic South Africa divides household monthly expenditure into five quintiles.

The table above shows that there's a different inflation rate for different groups of quintiles. Inflation is higher in the 'very low' quintile at 7.5% followed by the 'low' at 7.1%. This is higher than the average inflation rate of 7.0%. Thus the inflationary effect for lower income household is greater than household that earn 'high' and 'very high' income.

The province with an annual inflation rate **lower than or equal to headline inflation** were Northern Cape (6.2%), North West (6.5%), Mpumalanga (6.8%), Western Cape (7.0%) and KwaZulu-Natal (7.0%)

The provinces with an annual inflation rate **higher than headline inflation** were Gauteng (7.1%), Eastern Cape (7.5%), Free State (7.5%) and Limpopo (7.6%).

The consumer Price Index is known as the headline inflation rate and is also referred to as the official inflation rate. The month to month prices of over a thousand goods and services go into the calculation of CPI.

The food price index shows the increase in the price level of food products only, on a monthly basis. This rate is incorporated in the overall CPI inflation rate (CPI).

The transport price index provides an indication of the increase in then price level of transport items in the basket of goods and services that make up the inflation index. This rate is incorporated in the overall CPI inflation rate.

An administered price is defined as the price of a product, which is set consciously by an individual producer or group of producers and/or any price, which can be determined or influenced by government, either directly or through one or other government agencies/institution without reference to market forces. For example, school fees, telephone fees, electricity, trains, petrol/paraffin, cell calls and public transport. This rate is incorporated into the overall CPI inflation rate.
