

INFLATION MONITOR SEPTEMBER 2015

The Consumer Price Index (CPI) remained unchanged at 4.6% in September 2015

The term inflation means a sustained increase in the general level of prices for goods and services. It is measured as an annual percentage increase (for example September 2014 to September 2015).

The year-on-year inflation rate as measured by the Consumer Price Index (CPI) was 4.6% in September 2015, unchanged from August 2015

The Food price was 4.4% in September 2015, unchanged as in August 2015. **Transport inflation** was - 0.8% in September 2015 from -0.7% in August 2015 mainly due to a -69c litre decrease in the price of petrol.

Public transport inflation decreased by 1.8% in September 2015 from 2.4% in August 2015.

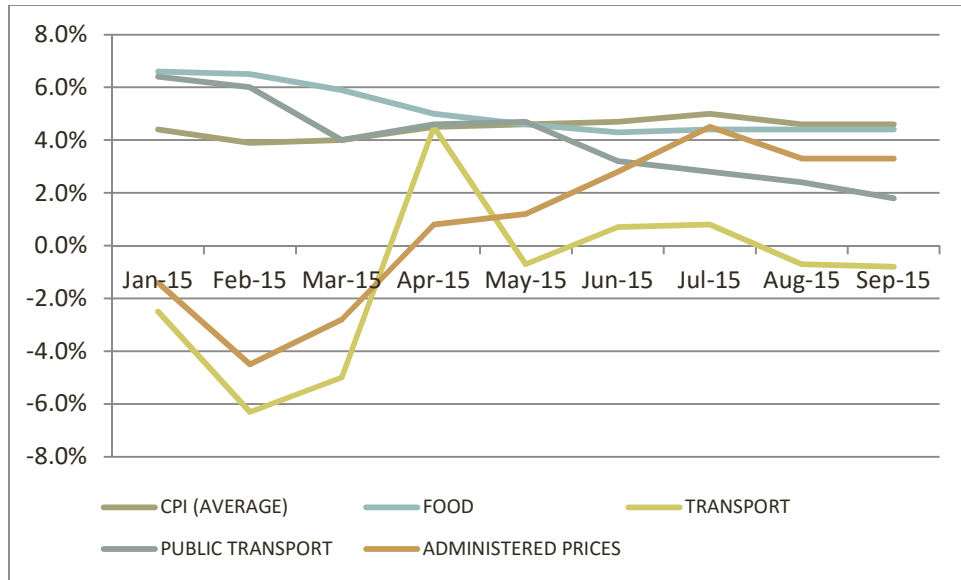
Administrator's price (school fees, telephone fees, electricity, trains, petrol/paraffin) was 3.3% in September 2015, unchanged from August 2015.

Housing utilities price increased to 6.4% in September 2015 from 6.3% in August 2015.

Consumer Price Index (CPI) Per Expenditure Quintile

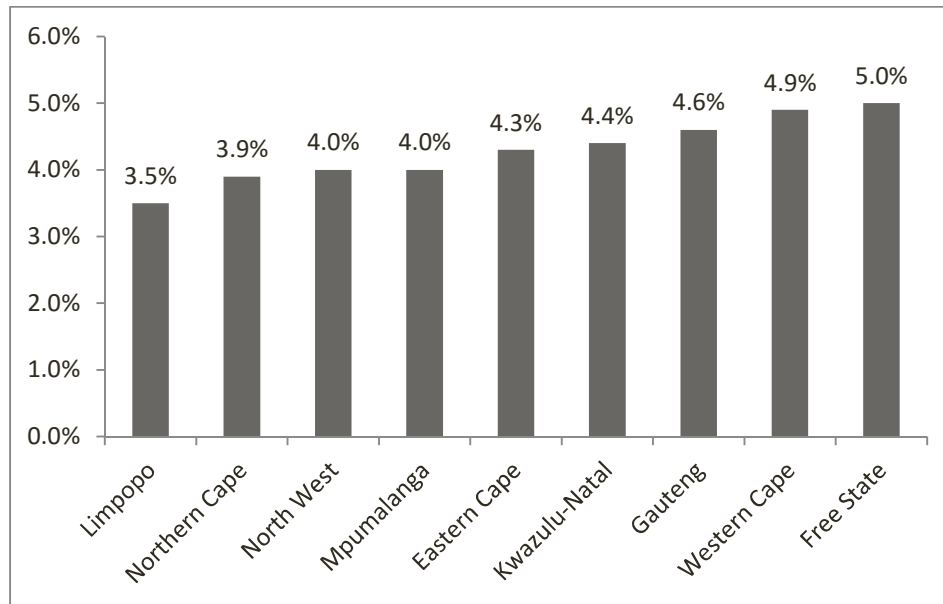
Statistic South Africa divides household monthly expenditure into five quintiles.

The table above shows that there's a different inflation rate for different groups of quintiles. Inflation is higher in the 'very low' quintile at 5.3% followed by the 'low' at 5.0%. This is lower than the average inflation rate of 4.6%. Thus the inflationary effect for lower income household is greater than household that earn 'high' and very high income.

The province with annual inflation rate **lower than or equal to headline inflation** were Limpopo (3.5%), KwaZulu-Natal (4.4%), North West (4.0%), Mpumalanga (4.0%), Northern Cape (3.9%), Eastern Cape (4.3%) and Gauteng (4.6%)

The provinces with an annual inflation rate **higher than headline inflation** were Western Cape (4.9%) and Free State (5.0%).

The consumer Price Index is known as the headline inflation rate and is also referred to as the official inflation rate. The month to month prices of over a thousand goods and services go into the calculation of CPI.

The food price index shows the increase in the price level of food products only, on a monthly basis. This rate is incorporated in the overall CPI inflation rate (CPI).

The Transport Price Index

The transport price index provides an indication of the increase in then price level of transport items in the basket of goods and services that make up the inflation index. This rate is incorporated in the overall CPI inflation rate.

An administered price is defined as the price of a product, which is set consciously by an individual producer or group of producers and/or any price, which can be determined or influenced by government, either directly or through one or other government agencies/institution without reference to market forces. For example, school fees, telephone fees, electricity, trains, petrol/paraffin, cell calls and public transport. This rate is incorporated into the overall CPI inflation rate.
